### What is an Exterior Color Change permit?

In order to implement the adopted Commercial Design Guidelines, the Town of Yucca Valley requires property owners to submit color swatches and an application for Exterior Color Change when changing the color of a commercial building. A permit is not required when the building is being repainted the same color.

### Who reviews the Exterior Color Change?

Exterior Color Change applications are reviewed and approved by Planning Division staff. Colors or color combinations not consistent with the Commercial Design Guidelines may be forwarded to the Planning Commission for review.

### Submittal Requirements

To apply for an Exterior Color Change permit, a completed application and color samples shall be submitted to the Planning Division.
